## Dec. 12: Sutter's Landing Park Community Meeting

Boulevard Park residents are encouraged to attend the community meeting about the future of Sutter's Landing Park. It will be held at the Clunie Community Center, 601 Alhambra Boulevard, on Thursday, December 12 (6-8 p.m.). The City of Sacramento is preparing a new Master Plan for the Park and wants your input.

Located north of Midtown, Sutter's Landing Park sits along the Lower American River and is immediately adjacent to the American River Parkway. It provides Midtown residents with their greatest access to nature and the river itself. The Park also includes additional features such as a section of the Two Rivers Bike Trail, two dog parks, a skateboard park, basketball courts, and a bocceball area.

The 215-acre Park provides important habitat for a variety of imperiled wildlife including Swainson's hawks that migrate each year from Central America, White-tailed kites (shown in the photo), Peregrine falcons, and many others. It is also Midtown's *Gateway to the American River*. That is why the Boulevard Park Neighborhood Association, the Marshall School-New Era Neighborhood Association, the Newton Booth Neighborhood Association, and the Environmental Council of Sacramento (ECOS) have all urged the City to protect, restore, and enhance the Park's habitat for native wildlife and to transform the Park into one of the most impressive and celebrated urban nature parks in California.

## **Report from the BPNA Board**

Much of the agenda of the BPNA Board meeting on November 7 involved neighborhood events. Noah Mebane reported on the very successful Hallowe'en "Trunk or Treat" event that was co-hosted by two neighborhood associations, BPNA and MNENA, outside the historic Marshall School on October 26. It featured games, face painting, free candy, and even a free movie (see the video and photos posted on our Facebook page: facebook.com/BPNABoardMember). The next BPNA event is the annual holiday party on Saturday, December 14 (see the article on page 1). Plans are underway as well for the general membership meeting, scheduled on Tuesday, January 14. Board members also discussed new and pending parking policy revisions in the City of Sacramento. Some revisions will result in the suspension of requirements for the provision of car parking spaces in some development projects, while others involve improved parking management and an increase in the number of bicycle parking spaces. 

# The Cranston-Geary House, 2101 G Street

For the first time in its history, this year's holiday party is being held at the Cranston-Geary house, the site of the BPNA's annual Spaghetti Dinner from 1998 until 2022. This handsome California Craftsman residence takes its name from the surnames of the first two families to occupy it: the Robert Cranstons, who had the house and its garage built on the double lot in 1909, and the William Gearys, who bought the property in 1912, and who lived here until the early 1940s. Robert Cranston was a mining engineer with the Natomas Company; William F. Geary was the vice-president of a firm of wholesale druggists, Kirk Geary & Co. The Geary family's long residency was well-documented in photographs, several of which were reproduced in the book *Sacramento's Boulevard Park*. One of those photographs shows William F. Geary, his wife Julia, and their four children (Katherine, William, John, and Mary) relaxing in front of the living room fireplace in the early 1920s.

Like several other large two-story homes in Boulevard Park, the Cranston-Geary house was designed by an architectural firm. Two Chicago-trained architects who had come to San Francisco after the 1906 earthquake, George C. Sellon and E. Charles Hemmings, set up an office in Sacramento in 1908, a year before they went to work for Robert Cranston. Their Chicago experience, which included contact with Frank Lloyd Wright, may have influenced some of the details of the Cranston-Geary house.

Distinctive features of the house include its multiple gables, the curved or flaring lines of the gable roofs, the exposed rafter ends, and the use of multiple materials – brick (chimneys and front porch), wooden lap siding (lower story), wooden board-and-batten siding (upper story), and even brass (the decorative ornaments along the rooflines of both the house and its garage). The patterns used in some of the leaded glass windows and in the interior woodwork (especially the wooden panels on the dining room walls) are not found anywhere else in Sacramento. The cast-iron hitching post on the G Street side of the house is another original feature and is even mentioned in the 1909 paperwork for the project. Unlike the neighborhood's other hitching posts, it has a lion's head instead of a sphere.

Because of its historic importance and the high quality of its design, the Cranston-Geary house was placed on the National Register in 1998, one of only two buildings in the greater Boulevard Park neighborhood to gain this recognition (the other is the Winters House at 2326 H Street).

#### **Council District 4 Meeting Thanks Katie Valenzuela, Connects Neighbors**

The second District 4 Community Meeting of the year was held on the evening of November 14th at the Hart Senior Center. Sponsored by Councilmember Katie Valenzuela, the event was posed as a mixer between neighborhood activists and city departments, as well as a transition to the district's new leadership under Councilmember-elect Phil Pluckebaum. The meeting was attended by around 50 community members, who were well-fed with offerings from Mendocino Farms provided by the Councilmember's office.

After some time set aside for attendees to arrive, exchange greetings, and engage with city staff, Councilmember Valenzuela gave a short speech thanking her own staff, the city, and engaged neighbors for their support throughout her term. She then handed off the mic to Mr. Pluckebaum, who introduced himself and his staff before welcoming the continuing commitment of the community. Pluckebaum ceded the floor back to the Councilmember, who called upon each attending city department to provide updates on the current goings-on. A brief listing of the attending departments and their topics:

Arts and Culture (Del Rio Trail art and historical installations, grant opportunities for venues and artists); Center for Sacramento History (wayfinding project in Old Sacramento); Community Development (2040 General Plan, Urban Forestry Master Plan); Youth, Parks, and Community Enrichment (Sacramento Children's Fund, new "Volunteers In Parks" program); Community Engagement (Communications Toolkit, monthly mixer, "Sac Vibes" podcast); Innovation and Economic Development (Railyards project); Transportation (Broadway Complete Streets, Streets for People initiative); Code Enforcement (graffiti cleanup effort); Public Safety Accountability (police and fire misconduct process); Sacramento Police (crime analysis tools); Sacramento Fire (Street Overdose Response Team); Community Response (Incident Management Team success).

Once each city office had spoken its piece, Councilmember Valenzuela called upon each present neighborhood association representative to introduce themselves and talk about past and upcoming endeavors (the BPNA was represented by board member Noah Mebane). A final farewell was made to conclude the meeting, and attendees were given a final opportunity to mingle and connect with each other and with the city's departmental liaisons.
